Pulsifer has reached out to the applicant about moving the garage the 5 feet to make the side yard 10 foot but has not yet heard back. Gordon questioned if they were going to remove the trees/shrubs. Grubb stated they need to be mindful of the leach field. The board discussed the space above the garage and the possibility of it being changed into a room in the future.

Should it be used for anything other than storage, they must return to the board to request it to be changed. Grubb seconded. All in favor, motion carried
