Chairman Robert Powell called the meeting to order at 7:00 pm

MINUTES:

The November 2019 minutes were approved as presented. **(Gordon/Leibeck)** A motion was made by Gordon and seconded to approve the November 26th 2019 minutes. All in favor and motion carried.

DISSCUSSION:

The Board discussed changing the meeting time to 6 pm instead of 7 pm to better accommodate the board members and the public.

(Gordon/Feeley) The board made a resolution to change the Planning Board Meeting time to 6 pm. All in favor, and the motion carried.

Powell, the Chairman of the board, brough up that the board is in need of a vice chair and that he would like to nominate Gregory Gordon. Powell asked the rest of the board of nominations. The board agreed to elect Gordon as the Vice Chairman.

Powell stated that the Dollar General had been looking to come to Willsboro. The Town seems to be half for and half against on this matter. Powell spoke with Shaun Gillilland, Town Supervisor, and he will arrange for Mark Schachner, the Town Attorney, to brief the board and help out when needed. Powell stated in the mean time the board needs to be prepared. He stated during the process the board will conduct a site plan review, SEQR, and possibly conduct an Environmental Impact Study (EIS). Powell suggested that all board member review the comprehensive plan, he suggests visiting a Dollar General as well. He also suggested Googling Dollar General and the impact it has on small businesses.

Powell stated that the Deed Mckenna wrote when he sold the parcel to Roger Long stated "its is anticipated that the buyer will construct a retail business on the subject land, they buyer shall be prohibited from the sale of gasoline, diesel fuel, kerosene, cigarettes and tobacco products, lottery, meat, fish and poultry products, beer wine and spirits, this condition shall apply to all airs, executers and successors in tile and shall survive the closing and be enforceable against any and subsequent owners." Powell states that is why Dollar General canceled their scheduled meeting and withdraw the application. However, Dollar General can buy a different piece of land and they could try to amend the dead. Powell stated with the SEQR review is does not just included the natural environment also include the business environment.
