PERMIT APPLICATION FEE SCHEDULE

Application fees do not include required electrical inspection fees by outside agencies.
An additional 50% of the application fee will be charged as a penalty for starting a project without a permit.

6. All Additions (including enclosed porches & attached garages)	
Per square foot	0.15
Fee based on square footage in #1-#4 above - Minimum fee	25.00
7. Repairs/Alterations (cost based on structural, plumbing, electrical work – not to exceed cost of #1-#4 above)	
Up to \$ 5,000.00	20.00
Over \$5,000, and each \$5,000.00	40.00

9. Decks or Open Porches (accessibility ramps on single-family homes – no fee)	
Per square foot	0.15
Minimum fee	35.00
10. Mobile Homes (aka: single-wide trailers; includes porches, decks & entries up to 50 sq. ft.)	75.00
11. Swimming Pools (additional fee for Town Water – see specific rate chart with application)	50.00
